HEALTH INSURANCE REQUIREMENT

All International students are required to carry their own health insurance while in the United States on a student visa. Students need to furnish their health insurance card to the Regis Catholic Schools Office to verify that they have health coverage.

Important Notice to Immigrant Visa Applicants Concerning Vaccination Requirements

United States law requires F-1 Students to receive vaccinations. The State Department website provides the comprehensive list of required vaccinations. Our school office will require a doctor certified vaccination report with the date the immunization was received.

ACADEMIC & ATHLETIC REQUIREMENTS

GPA (Grade Point Average): For an F-1 visa student, minimum of 2.5 cumulative GPA must be maintained. Global Outreach and Regis Catholic Schools work cooperatively to provide an **academic program**; you must maintain a 75% or higher in every class. Initial: _____

Failure to maintain the minimum will put the international student on academic probation. If the international student feels that they are in jeopardy of not earning a 75% they should tell the (P)DSO immediately. The (P)DSO can request a Success Plan from Global Outreach. When the probationary period is expired as directed by SEVP.DHS.ICE, if there has not been improvement, then the F-1 visa student is at risk of being *terminated* from SEVP for "poor academic performance." Each year, prior to the first day of school, incoming students must meet with Ellen Killian, International Student Advisor, to review their paperwork (passport, I-20, I-94, previous school records, grades and proof of inoculations). International students are to keep, Ellen Killian, International Student Advisor, aware of their current address in the United States at all times. Any student that will be leaving the United States for any reason while on their student visa must have their I-20 signed by the International Student Coordinator before leaving the country.
